Presidential Succession Act. July 18, 1947. On July 18, 1947, President Harry Truman signed the Presidential Succession Act. The original act of 1792 had placed the Senate president pro tempore and Speaker of the House in the line of succession, but in 1886 Congress had removed them. The 1947 law reinserted those officials, but placed the Speaker ahead of the president pro tempore.

The United States Presidential Succession Act is a federal statute establishing the presidential line of succession. Article II, Section 1, Clause 6 of the United States Constitution authorizes Congress to enact such a statute: Congress may by Law provide for the Case of Removal, Death, Resignation or Inability, both of the President and Vice President, declaring what Officer shall then act as President, and such Officer shall act accordingly, until the Disability be removed, or a President ...

1787: Presidential Succession -- February 20, 1792. Long before Secretary of State Alexander Haig assured the nation that he was in control during the crisis period following the 1981 shooting of President Ronald Reagan, members of the Senate had tried to block that cabinet officer's chances of temporarily assuming the duties of the presidency.

U.S. Senate: Presidential Succession

The meaning of “presidential line of succession” is that it is legislation dictating the process by which the federal government delegates presidential responsibilities, should something happen to the President. For example, the presidential line of succession kicks in if a President dies while in office or becomes impeached.
